Call to Order

- 3. **Approval of Minutes:** Chair Weintraub entertained a motion to approve the January 17, 2025, Public Meeting minutes. Commissioner Fritz moved; Commissioner Scheel seconded. The vote was unanimous, with all Commission Members voting aye. The motion carried.
